Directions and Goals

eHLbc's 2024-28 Strategic Framework offers a flexible planning approach for the future, mobilized by four core directions. The consortium adopts shorter cycles (2-3 years) to establish goals, facilitating frequent evaluation and necessary adjustments to ensure progress meets members' needs.

Short term goals were reviewed by the Management Committee and updated with input from the All Member Group in June 2025.

1. Support eHLbc Members

2-3 Year Goals:

- Investigate current and future accessibility needs of consortium and map internal/external considerations.
- Evaluate the accessibility and efficacy of eHLbc orientation materials.
- Host a 1-hour virtual "Gathering Space" at least twice a year to provide members opportunities to connect around issues of shared interest.

2. Optimize Professional Development

2-3 Year Goals:

 Facilitate member-to-member learning opportunities, driven by needs assessment.

3. Grow Collection of Opt-In Resources

2-3 Year Goals:

- Review the eHLbc Electronic Suggestion Box (eBox) and Ranking Survey processes to ensure the consortium is pursuing appropriate resources.
- Hold a virtual discussion to hear how medical research landscape is changing, impacts on publishing trends, and opportunities to leverage new resources.

4. Maintain a Core Suite of Resources

2-3 Year Goals:

- Align terms and conditions for Core Suite vendors with those in the eHLbc model license, ensuring they reflect eHLbc values and BC Accessibility standards.
- Increase awareness of the content and scope of eHLbc's core resource suite.
